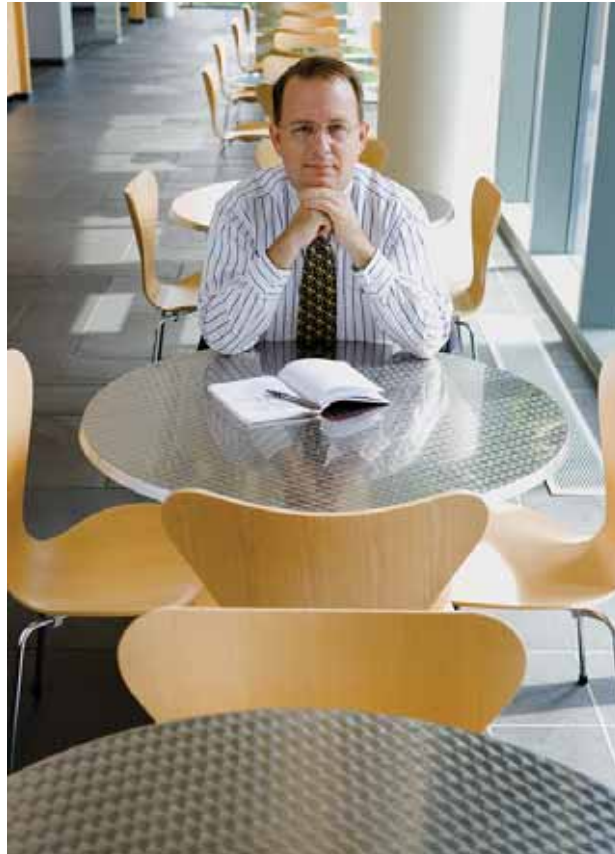

Inspired and mentored by an architect-neighbor, Ron Geyer decided on architecture as a career in his early teens and continues to use his life experiences to fuel his passion for designing what he refers to as "gathering places."

One of Ron's first projects when he joined Craig Gauden Davis in early 1984 was the Peace Center for the Performing Arts, followed quickly by performance spaces for the University of Georgia, the University of South Carolina and the historic Newberry Opera House. These high-profile successes showcased his ability to discover a unifying concept and to rally diverse groups of people behind it.

By working with organizations to identify and articulate their mission, Ron creates facilities that serve and advance that mission, beautifully and practically.

Along with his wife and three children, Ron participates in a range of church activities, from leading short-term overseas mission trips to managing the church's website. He has also held leadership positions with Habitat for Humanity and the Greenville County Redevelopment Authority.
